2. The Afar National Regional State Bureau of Water, Irrigation and Energy now invite sealed Bids from eligible Bidders for 2 Deep wells Drilling and Construction in Dalol & Telalak Woredas in 2 Lots- Lot 1: Dalol Woreda Farisbora Kebele and Lot 2: Telalak Woreda Gewto Kebele.

Bidding will be conducted through the National Competitive Bidding (NCB) procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers World Bank's Procurement Regulations for IPF Borrowers" July 2016, revised November 2017 and August 2018 and is open to all Bidders as defined in the Procurement Regulations.

Interested bidders have to provide information on available manpower, equipment & machinery, accessories & tools, vehicles, experience in similar projects as well as renewed Water Works Registration and Trade License for the year 2012 E.C, VAT, and TIN certificate and other relevant information as specified in the bidding document.
