Currently, the organization is engaged in social and development programmes as well as emergency interventions.

DoC is dedicated to safe Procurement and programming. 2. Bidders must obtain renewed valid trading license for the specified item

3. Bidders must have TIN number, VAT certificate and other relevant documents such as certification of the product
4. The bidders cannot alter, amend or withdraw offers after tender is opened
5. Bidders should submit offers price as per the attached request for quotation.
6. Bidder should aware that before conducting an agreement due diligence is going to be conducted on the overall capability of a supplier.
7. The supplier should deliver the material within three consecutive days after notification of award and signing of agreement with contract security of 10% from the total price he/she wined
8. The materials should have at least 6 months Expiry date assurance
9. Bids must be delivered their bid documents to the address Daughters of Charity coordinating office subcity of Adihaki behind Adihaki eye clinic first floor in the prepared tender box, from 12/12/2023 up to 15/12/2023.
