Call for Consultancy on Local software development and IT installation

BACKGROUND

The three agencies have over 40 years of experience in international development and humanitarian response and are each member of worldwide networks, including Caritas Internationalis. Currently, the three agencies jointly operate a single, integrated country programme in Ethiopia through the legal entity CST Ethiopia.

CST is a partnership organization and for the ICSP project it is planning to support the implementing partners on selected IT system establishment and strengthening as part of its capacity strengthening. The technological tools that assists partners of CST by helping them to work with greater productivity in forwarding the overall organizational mission. To that end the IT Infrastructure should enable internal and external organizational communications, enable measurement and evaluation and of projects and initiatives.
