6. Bidders should submit Bid security of 50,000 (fifty thousand birr) bank C.P.O
7. Bidder should aware that before conducting an agreement due diligence is going to be conducted on the overall capability of a supplier.
8. The supplier should deliver the material within 10 days after notification of award and signing of agreement
9. The supplier should deliver the materials to DoC coordinating office with his/her own transport
