3. Bidders must have TIN number, VAT registration certificate or TOT.
4. The bidders cannot alter, amend or withdraw offers after tender is opened
5. Bidders should submit offers price as per the attached request for quotation.
6. Bidders should submit Bid security of 50,000 birr (Birr fifty thousand) only in CPO & it should be submitted together with the bid document to the bid box before the bid opening time.
7. Bids must be delivered their technical and financial bid documents one original and one copy to the address Daughters of Charity coordinating office sub city of Adihaki behind Adihaki eye clinic first floor in the prepared tender box, from 19/07/2024 up to 25/07/2024.
8. Bid opening date is 25/07/2024 at 8:30 local time
9. Late bids will be rejected and Bids will be opened physically on 25 /07/2024 at 9:00 local time preferably in the presence of the bidders or representatives who choose to attend in person at the address
