4. Suppliers should submit bid security thousand birrs/ only in CPO and it 20.000.00/one hundred twenty submitted together with the bid Document to the bid box before the bid clothing date.
5. The bidders cannot Altere, amend or withdraw offers after tender is opened.
6. The bid Validity date is 60 days.
7. The tender documents must be marked clearly, bidders name, address and legal stamp

of the supplier and submit in sealed envelope to ACSOT office, located in Mekelle City, Hawelty-city, Tabia Selam, Egri-mitkal Building, Second floor.
