3. Bidders must have TIN number and VAT registration certificate.
4. The bidders cannot alter, amend or withdraw offers after tender is opened
5. Bidders should submit offers price as per the attached request for quotation.
6. Bidders should submit Bid security of 50,000(fifty thousand birr) bank C.P.O and should be submitted together with the bid document to the bid box before the bid closing time.
7. Bidder should aware that before conducting an agreement due diligence is going to be conducted on the overall capability of a supplier.
8. The supplier should deliver the material within 10 days after notification of award and signing of agreement
9. The supplier should deliver the materials to DoC coordinating office with his/her own transport
