EOI REQUIREMENTS

Interested and capable service providers or agency service providers must:

1. Have a legal working license to provide end-to-end services- Provide proof of working license in the Security guarding service sector together with a TIN certificate and the license must be renewed for the current year. Interested candidates shall provide all legal documents including a Commercial Registration certificate, Memorandum of Association, Recognition certificate from the Regional police office, and Trade name registration certificate.
2. Have considerable experience providing similar services - Provide a corporate client reference where you have provided similar services on security guarding services.
3. Provide a compliance document and proof of maintaining the health and safety of the work environment - provide a detailed method and procedures taken to maintain the health and safety of workers and the working environment.
4. Demonstrated experience of a minimum of 3 years in a Multicultural company.

Administrative Requirements

1. Provide a detailed company profile with a professional background.
2. Provide a detailed technical proposal for the required service.
3. Provide a signed health and safety compliance letter.

Provide a duly completed statement of compliance (that is whether you are fully compliant, partially compliant, or non-compliant) to each of the above items.

- No prices should be provided with this EOI.
- The receipt of the response shall not bind Safaricom to any contractual agreements with the prospective bidder. Such arrangements shall only come into place once a tender process has been completed and an award issued to a successful bidder after technical evaluation.
- Any costs associated with preparing and submitting the response to the EOI shall be borne by the respondent.
