3. The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of birr 1000.00. The method of payment will be in cash.

All Bids must be valid for a period of Ninety (90) days after Bid opening and must be accompanied by bid security of birr ETB 200,000.00(Two Hundred thousand birr) in the form of unconditional Bank Guarantee, or CPO and they shall be delivered to the above office on or before bid closing date at (9:00 A.m. on 10/03/2025).

5. Bids must be delivered to the address below; bidders should offer in Addition to the original of the bid one Copy of technical and Two copies financial proposals sealed in separate envelop as specified in the bidding documents to be provided.
