The deposit slip must also be attached to the tender package as the first page, as part of the requirement for the contractor to be considered when submitting your tender (technical and financial documents). Tender package can be obtained by hard copy at SOS children's villages in Ethiopia, national office and SOS children's villages in Ethiopia, Mekelle location office.

Only bidders that have a specific/related license and have related work experience with the

same scope of works or beyond. Submissions by tenderers not belonging to those categories will lead to automatic rejection. Temporary joint ventures will not be taken into consideration.

The bidders must comply with all the instructions, terms and conditions and ensure that all forms required are properly completed and submitted.

The Financial offers to be submitted at the same time as the technical documents. And the submission process will be, the technical proposal and financial proposal will be delivered in a single or separated and sealed envelope to the following address:
