3. Those who can provide a legal formal witness letter that the supplier has registered license in the fiscal year to provide similar services
4. Providing all necessary documents with legal stamps and signature.
5. The Sport items to be procured, then the winner of the bid will be expected to deliver the

item to the specified places with his/her own transportation cost. Then the price to be fill must consider these costs too.

6. The items shall the same with the available sample, with no different size must be alike to each other. A sample of Sport item is available with us for ease of provision as per the sample.

7. The winning seller must make a formal agreement with us in seven days from the time he/she is notified and who can proving that the Sport Items are delivered in proper specification as per the sample given..
