- Valid and renewed trade license for the current fiscal year.
- Tax clearance certificate and VAT registration.
- License for a Cash Register Machine (CRM) or a verified e-Invoice.
- Relevant professional licenses for security service provision.
- Evidence of prior experience in managing security for large-scale industrial or governmental facilities.

A complete set of bidding documents in English may be purchased by interested bidders upon payment of a non-refundable fee of ETB 400.00 (Four Hundred).

#### 5. Submission and Opening

- Submission Deadline: Bids must be delivered to the address below on or before January 30, 2026 at 10:00 am (before lunch time).
- Bid Security: All bids must be accompanied by a bid security of ETB 50,000.00 (Fifty Thousand) in the form of a CPO or Unconditional Bank Guarantee.
