## 1. Scope of Works

## 2. Eligibility Requirements

Bidders shall meet the following minimum eligibility criteria:

- o Evidence of settlement of 2018 E.C. tax obligations

### 3. Bid Security

- o Bidders shall furnish a bid security of ETB 100,000.00 (One hundred Thousand Birr).
- o The bid security shall be submitted in the form of CPO only, issued by a bank authorized by the National Bank of Ethiopia.
- o The bid security shall remain valid for Thirty (30) calendar days from the date of bid opening.

### 4. Completion Period

The successful bidder shall complete the renovation works within sixty (60) consecutive calendar days from the date of site handover.

### 5. Tender Document Purchase

From TDA Head Office, Office No. 435, upon payment of a non-refundable fee of ETB 500.00 (Five Hundred Birr), with in the period April 8, 2026, to April 28, 2026, during regular working hours.

### 6. Bid Submission
