The Organization intends to implement classroom maintenance work in Tigray region public secondary schools (in Axum, Adwa, Guya, Mekelle & Samre), Ethiopia

Upon receipt of the payment confirmation and verification, they will receive the tender package. The deposit slip must also be attached to the tender package as the first page, as part of the requirement for the contractor to be considered when submitting your tender (technical and financial documents). Tender package can be obtained in hard copy at the SOS children's villages in Ethiopia, National office or Mekelle program location office.

Only contractors belonging to Categories/Grade 6 (Six) and above Building Contractors, (of

the classifications of the Ministry of Public Works Ethiopia are allowed to tender). Submissions by tenderers not belonging to those categories will lead to automatic rejection. Temporary joint ventures will not be taken into consideration.

The bidders must comply with all the instructions, terms and conditions and ensure that all forms required are properly completed and submitted.
