mandated public body.

ITB3.2(b)Renewed or valid trade license on WWCC for the fiscal year 201 0, registration certificate from Ministry ofWater, Irrigation and Electricity or from Tigray water resource bureau for the fiscal year, tax clearance certificate,VAT-declaration for the month of June 201 0 (Sene, 201 0),VAT registration certificate,Tin Certificate ,suppliers registration certificate and any relevant professional practice certificates.

3. ITB 18.1 The written confirmation of authorization to sign on behalf' of the bidder shall initialed and approved by authentication office.

4. Bidders should submit one original & 2(Two) Copies of Financial documents and 1 (one) Original Legal documents(licenses) and 2(Two) Copies of Legal documents (licenses) also must be provided in separate envelopes.

8. All bids shall be accompanied by UN conditional bid Security in the form of (CPO) birr 120,000. The bid shall be valid for a period of 60 (sixty days) after bid opening plus 28 days beyond the bid validity period. and submitted together with the original legal requirements.
