Method of payment will be in cash against receipt. Bidders are required to attach with their application, a copy of their renewed trade licenses, VAT certificate, Tax clearance and TIN certificate.

6. Bids must be delivered to the address below at or before 10:00A.M on April 2, 2024. Electronic bidding shall not be permitted. Late bids will be rejected.

7. Bids will be publicly opened physically in the presence of the bidders' representatives who choose to attend in person at the address below at 10:30 A.M on, April 2, 2024.

All bids shall be accompanied by a Bid Security of ETB 200,000.00 (Two Hundred Thousand Birr) in the form of Unconditional Bank Guarantee or CPO to Mekelle Water supply and sewerage service office and shall remain valid for 148 (One Hundred Forty-Eight) calendar days.. For Bank Guarantee the bidder must use the bank guarantee form included in section IV (Bid Form) of the bidding Document.

9. Bid shall be valid for period of 120 days after Bid Submission deadline.
