2. Bidders must obtain renewed valid trading license for Bread
3. Bidders must have TIN number and VAT registration certificate.
4. The bidders cannot alter, amend or withdraw offers after tender is opened
5. Bidders should submit offers price as per the attached request for quotation.
6. Bidder should aware that before conducting an agreement due diligence is going to be conducted on the overall capability of a supplier.
7. The supplier should deliver the material within 1 working Days after notification of award and signing of agreement
8. The supplier should deliver the materials to DoC coordinating office with their Owen transport
9. Bids must be delivered their financial bid documents to the address Daughters of Charity coordinating office sub city of Adihaki behind Adihaki eye clinic first floor in the prepared tender box, from 10/07/2024 up to 16/07/2024.
10. Bid closing date is 16/07/2024 at 8:30 local time and Bids will be opened with the same date physically at 9:00 local time preferably in the presence of the bidders or representatives who choose to attend in person at the address above.
11. The winner supplier is going to sign an agreement for three (3) month with fixed price and may renew as required.
12. Late bids will be rejected.
