2. Bidders must obtain renewed valid trading license for training service
3. Bidders must obtain Business registration certificate with Accounting and Auditing Board of Ethiopia (AABE)
4. Bidders must have TIN number, VAT registration certificate and TOT
5. The bidders cannot alter, amend or withdraw offers after tender is opened
6. Bidders should submit offers price as per the attached request for quotation.
7. Bidders should submit Bid security of 50,000 birr (Birr fifty thousand) only in CPO & it should be submitted together with the original technical bid document or separately to the bid box before the bid closing time.
8. Bids must be delivered their technical and financial bid documents one original and one copy to the address Daughters of Charity coordinating office sub city of Adihaki behind Adihaki eye clinic first floor in the prepared tender box, from 04/12/2024 up to 09/12/2024.
9. Bid closing date is 09/12/2024 at 8:30 local time
10. Late bids will be rejected and Bids will be opened physically on 09/12/2024 at 9:00 local time preferably in the presence of the bidders or representatives who choose to attend in person at the address above.
