The Government of the Federal Democratic Republic of Ethiopia has received financing from the World Bank toward the cost of the One WaSH National Program (CWA-II) and intends to apply part of the proceeds toward payments under the contract for Drilling of Shallow wells, Supply, and Installation of Afredeva Hand Pump at Health Centers of Tigray. "For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines

for Investment Project Financing."

Tigray Water and Energy Bureau now invites sealed Bids from eligible Bidders for the drilling of shallow wells, supply and installation of Afredeva hand pumps, Lot-1 #12 (Ahfero, Naeder, Chila, Laelay Maychew, and Asgede) and Lot-2 #17 (Geralta, Samre, Atsbi, Sewha saesie, Esra Adi Wojerat, Silawa, Raya Alamata, and Ofla) completion period 5 days per shallow well and no margin of preference is applied.

Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers Projects Financing, dated July 2016, revised November 2017 and August 2018, and is open to all Bidders as defined in the Procurement Regulations.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below Tigray Water and Energy Bureau at 3:15 Local Time, 21 February 2025.
