The government of the Federal Democratic Republic of Ethiopia has received financing from the World Bank toward the cost of the second urban water supply and sanitation project, and intends to apply part of the proceeds towards payments under the contract for #2 Double cup field vehicles for restoration of Adigrat Town Water Utility.
