Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA credits & Grants by World Bank Borrowers [Guidelines edition January 2011), (Procurement Guidelines), and is open to all eligible bidders as defined in the Procurement Guidelines.
