presence of bidders or their legal representative and ECC- SDCOA North West Project Office concerned committee.

3 ECC- SDCOA will open the bid March 24, 2020 G.C in venue of ECC - SDCOA Adigrat Main Office in the presence of bidders or their legal representative and ECC-SDCOA North West bid committee at 10:30 am (4:30 local time morning) in Adigrat Main Office .
